

**REER 2010 McKay Tract
Conditions of Permitted Use Agreement**

I acknowledge that permission to ride my horse on the McKay Tract (owned by Green Diamond Resource Company and leased by Redwood Empire Endurance Riders, hereinafter referred to as REER) is granted upon reading and signing the Release of Liability statement, signing this Conditions of Permitted Use Agreement, and paying REER club membership fees and McKay Tract fees. Attached to this application must be a photograph or photocopy the size of one square inch. A permanent rider card will be issued and must be with you at all times. Riders are to report any and all violations of permitted use.

1) Use of the McKay Tract is limited to permitted-riders only. No other riders will be allowed at any time. Allowing any other rider or person access will result in immediate revocation of rider's permit and forfeit of all fees. Permit is for one person and does not extend to family members. RIDER'S PERMIT IS NOT TRANSFERABLE AT ANY TIME.

2) Rider accepts all responsibility for their actions and non-action that result in damage to persons, property and animals. No dogs or any non-equine animals are allowed. Rider must be in control of their horse(s) at all times. No loose or uncontrollable horse(s) are allowed.

3) Permit is valid any daylight hours January 1 through December 31. Permitted use is restricted to the McKay Tract only. The rider will receive a map of designated trails that are available. Riding is restricted to these designated trails. There may be times, due to logging operations, other related work or where there is extreme weather that access may be temporarily denied and rider is required to comply. Routinely call Tom McDonald 498-4519 to check on road conditions or other warnings.

4) Good horsemanship and trail riding etiquette applies, such as, but not limited to the following: riding to the right, no galloping to pass riders, allowing vehicles to pass, humane treatment of horse, allowing others to pass on the left, assisting others in need, common courtesy, controlling your horse if it is predisposed to kicking and packing out what you bring.

5) Riders under 16 years must be accompanied by an adult (over 18 years) at all times. REER strongly encourages all riders, and especially minors, to wear a helmet.

6) No overnight camping is allowed unless notified and approved by REER. No fires, no smoking and no night riding. All riders must enter and exit the gated entrance at all times, and must leave no later than 30 minutes before dusk. The entrance and exit road is via Harris Street next to Redwood Acres. Riders will have access to the locked gate with a non-transferable key. This gate must be KEPT LOCKED at all times. Riders must to sign in and out on the attendance book at the gate.

7) Parking along roads must NOT block any roads or any vehicles. Park at your own risk. This is an unimproved area, and as such, the road shoulders may be soft in wet weather.

8) No bicycles, all terrain vehicles, motorcycles, “four wheeling” or any other wheeled form of transportation is allowed. All vehicles are limited to main access road and related shoulder areas.

9) Do not leave any trash. Horse droppings and feedstuffs are to be disposed of (at the trailer areas) by tossing them into the surrounding brush (if they are not packed out).

10) Failure to comply with any one of these Conditions of Use can result in loss of access and forfeiture of fees.

11) It is important to understand the nature of these conditions, as we are permitted “guests” on a working timber operation. The purpose of granting a rider access is to enjoy the enjoyment of their equine companion and to respect the natural beauty around us. Our philosophy is to leave little or no impact so that others can also enjoy the area. Anyone acting irresponsibly jeopardizes the future enjoyment of riding for REER members and ALL HORSEBACK RIDERS. We trust that good judgment and good horsemanship will always prevail. Happy Trails!
